

# **2025-2026 Precept Consultation**

Consultation Feedback Report

### **Executive Summary**

Cheshire Fire Authority has a duty to consult when considering the amount of precept it will levy for the provision of fire and rescue services across Cheshire.

Part of the budget setting process for 2025-2026 is to consult on the proposed level of precept to be charged by the Authority for the financial year. A detailed overview of the financial planning process is provided in the covering report submitted to the Fire Authority meeting of 12 February 2025.

This report provides details of the feedback received through the consultation process.

#### **Consultation process**

An online consultation was held for five weeks between December 16 2024 and 27 January 2025, which was hosted externally on www.surveymonkey.com.

The consultation was promoted through the issuing of a press release, social media posts, the Service's website and the use of the Service's Neighbourhood Alert email system.

A total of 288 responses were received.

#### **Feedback**

Respondents were asked to what extent they would support the Authority increasing its 2025/2026 precept by the equivalent of £5.00 per year on a Band D property. 63.9% of respondents indicated their support for the proposed increase, compared to 27.1% who opposed the increase. A further 9% of respondents stated they neither supported nor opposed the increase in precept.


There were 169 additional comments provided. Of these, 56 comments expressed support for the proposed increase, with themes centring around the service being a vital service that needs properly resourcing and the increase being relatively small in monetary terms.

There were 53 comments which opposed the proposed increase. Themes from these comments included the impact on low earners and pensioners given other impacts such as the withdrawal of the winter fuel allowance; the cumulative impact of precept increases from a range of authorities, and the need for the fire and rescue service to cut out waste, improve efficiency and concentrate on its core functions.

# Are there any comments regarding this proposal that you wish to make? (169 comments)

- The proposed increase is obviously needed. However, with the potential proposed additional increase in council tax, this will cause more financial pain and austerity for CEC residents
- A £5 increase on the Band D is reasonable. Thank you.
- £5 pa is necessary to maintain the service in line with inflation.
- They do a fantastic job in the local community and support when required
- The Fire Service and Ambulance Service are worth every penny they require.
   We should NEVER underfund these services, which are there to protect and save lives. I would happily pay this small increase.
- Would rather the fire stations remained funded than closed
- In the circumstances this seems very reasonable.
- It's been very helpful to know what % is covered locally and by government. It's also been helpful to have an explanation of how the increase is to be used. Thank you for providing this. I think if residents know why there's an increase and what it's to be used for, which I am certain can't always be provided, then they will be understand better the need for the increase.

- This proposal represents a 5.5 percent increase in the precept, more than

Having spent this amount and done all this work, I don't think they will need to spend so much on capital in projects in the next year, so therefore should need less expenditure.

'Only' £5 for a Band D property might not sound like much, but combined with other increases in Council tax, water rates, energy and food prices, this is all adding up to to much pressure on household budgets. There is only so much money you take from people, and the limit has been reached.
- Every year this survey goes out, no matter what the objections the precept is raised each year, so what's the point? No doubt Cheshire Constabulary will be along next with their annual increase. Why is there a difference in house bindings to what people contribute. I assume the presumption is if you live in a higher band property you can afford to pay more. The reality is many who live in higher band properties bought their homes a long time ago, worked to pay off their mortgages and are now pensioners on a fixed income.
- Like all public services the fire service should be clear about how it is being more efficient and effective in the future.
- Over the years cheshire fire and rescue have reduced the fire cover in Northwich and Knutsford areas and given bonuses to the fire chief and that this as a tax payer in not to keep putting it up every year. As a tax payer i cannot afford to keep paying these increases to council when I don't get any value for money from them.
- I think the council is inefficient and should make efficiency savings I get very little for my council tax as it is.
